Proposed Action

That the Metropolitan Council adopt an amendment to the 2025-2028 Transportation Improvement Program (TIP) to add MVTA's Apple Valley Transit Station Modernization project.

Background

The request is to add this project, which had been included in the 2024-2027 Transportation Improvement Program (TIP) as a 2024 project, into the 2025-2028 TIP as a 2025 project. The reason for this is that the project was originally scheduled for a 2024 obligation but fell into 2025. This project was funded in the Regional Solicitation.

Rationale

The Metropolitan Council approves formal amendments to the TIP. The project is consistent with the Transportation Policy Plan (TPP) and meets fiscal constraint because the federal and state funds are sufficient to fully fund the project.

Thrive Lens Analysis

On Feb. 12, 2025, the Council adopted Imagine 2050, which builds on policy direction in Thrive MSP 2040. Under the Thrive lens, this action promotes *stewardship* by enabling use of federal funding.

Funding

This project is fully funded with federal and local funds.

Small Business Inclusion

MVTA works through the Council's grant administration team in coordination with OEEO and Procurement to include DBE requirements on relevant projects.

Background and TIP Amendment Need
